MINUTES OF 192ND SYNDICATE (SPECIAL) MEETING HELD ON 28.11.2024

Decision of CAC: The Syndicate has gone through all subjects in the minutes of the 89th Finance Committee and approved the same with following recommendations.

Sub. I (9): Conducting University exams through Tabs.

Deliberation: The Members of the Syndicate expressed their concern over conducting of University Exams through Tabs and requested to have a visit to the examination centers where such type of examinations are being conducted and to have a live demonstration of such examination process. Also, suggested the University to study all the possible security features before implementing it. Many members felt that the university should adapt newer technologies in the examination system, as RGUHS is known for implementing latest technologies like digital valuation, web streaming, peripheral scanning etc. Many Universities across the country have visited RGUHS and followed the system adapted by it. It was also brought to the notice of the Syndicate that no decision has been taken about any business model to be adapted to procure digitabs. It will be decided later in concurrence with the Syndicate. Few Members expressed their desire to visit the examination center when digitabs are being used.

Decision of Syndicate It was decided to implement the plan of using digital tabs in the examinations after following all due procedures and making sure that all the security features are in place.





After deliberation all the members unanimously nominated Prof (Dr) P S Shankar as the RGUHS Syndicate Nominee to the Search Committee.

The Vice Chancellor said that he has high regards towards Prof (Dr) P S Shankar who is a very renowned personality in the field of Medical Education. SUBJECT 192/III (2): COMPLAINT RECEIVED BY THE MEMBERS OF THE SYNDICATE REGARDING IMPERSONATION, MALPRACTICE AND CHEATING IN ALL EXAMS BY MR. TARUN REDDY STUDYING MBBS.

Deliberation: The members of the Syndicate brought to the notice of the Syndicate that they are in receipt of the complaint regarding impersonation, malpractice and cheating in examination by Mr. Tarun Reddy who is studying in MBBS. The members expressed their concern that it appears that the people inside the university have helped him, insisted an enquiry and to take stringent action against the persons involved in the case. They mentioned that the said candidate was the son of the previous Registrar Evaluation, RGUHS.


At this point it was brought to the notice of the Syndicate that Mr Tarun Reddy was admitted to Saptagiri Institute of Medical Sciences in 2018 without qualified NEET score. He has failed twice in all the subjects in the 1st MBBS examination. Then he was allowed to write the examination in Bangalore Medical College & Research Institute by the then Registrar Evaluation who was also a faculty of the same institute. Surprisingly, the answer scripts issued to Saptagiri Institute of Medical Sciences were provided to the candidate to write the examination. In this examination he passed in all the three subjects of 1st MBBS. Further, he took transfer to Raja Rajeshwari Medical College. There he passed in all the subjects which he appeared.

At that time the University received many complaints regarding malpractice involving this candidate's examination process and his father who was the Registrar Evaluation, RGUHS. The Hon'ble Governor on receipt of similar complaints also wrote to the RGUHS to enquire into it. The Registrar at that time conducted an enquiry and gave a clean chit to the Registrar Evaluation.

The University continued to receive complaints against Mr Tarun Reddy regarding his involvement in the alleged malpractice in the examination. Hence, the center for all the candidates of RS3 batch of Raja Rajeshwari Medical College was shifted to St Johns Medical College for January - February 2024 examination. However, at this center Mr Tarun Reddy abstained from appearing for this examination in all the subjects for which he had applied.

In June - July 2024 examination, the center was shifted from St Johns Medical College to M S Ramaiah Medical College on the initiative of the present Registrar Evaluation, who mentioned that many students had requested for the change of examination center. At this center the said candidate appeared

for only two subjects and abstained from other two subjects. He passed in two subjects which he attended. Incidentally the candidate obtained 39 out of a maximum of 40 marks in the Viva Voce of both the subjects in which he passed.

Based on the facts placed the members opined that prima facie it appears that a lot of irregularities have taken place and action should have been taken long back.

Decision of the Syndicate: The Syndicate authorised the Vice Chancellor to form a committee to conduct detailed inquiry into these alleged irregularities.
