



1. Some of the members raised concerns about some Private Universities and Deemed to be Universities are running courses under RGUHS & their respective universities. The Syndicate decided that such Universities should be intimated to mandatorily continue such courses either under RGUHS or their respective universities only.
2. The Syndicate resolved to issue a circular regarding the change of name and adoption of a common nomenclature for Allied Health Sciences Colleges affiliated to RGUHS. A single proposal with such colleges shall be forwarded to the Government.
3. **Creation of accident insurance scheme:** The Syndicate resolved for creation of an accident insurance scheme for both permanent and outsourced employees of the University who lose their lives during service. This scheme will provide a death benefit fund of up to ₹ 50.00 lakhs for the employees who pass away during the service in the University. The annual
