

APPLIED FOR: FRESH MBBS COURSE 100 SEATS.


Decision of CAC: Based on the observations made by the inspection committee and scrutiny committee there is a staff deficiency of 100%, As per the NMC MSR they may not be eligible for fresh MBBS 100 seats. In case the Government issues an undertaking to satisfy the deficiencies as per MSR of the staff and infrastructure the same maybe considered.

Decision of Syndicate: The Syndicate accepted the recommendations of CAC.

SUBJECT II: ANY OTHER MATTER WITH THE PERMISSION OF THE CHAIR.

SUBJECT II (1): DISCHARGE OF STUDENTS (NON-KARNATAKA) WHO HAVE SECURED BELOW PERCENTAGE IN 10+2 IN (PHYSICS, CHEMISTRY AND BIOLOGY) ADMITTED TO BAMS COURSE AT AYURVEDA COLLEGES FOR THE YEAR 2023-24 - REG.

As per Regulations of RGUHS 2022 and KEA Notification, for General Category students minimum percentage is 50 % in 10+2 (taken together in Physics, Chemistry and Biology) and for SC/ST/OBC students minimum percentage is 45% in 10+2 (taken together in Physics, Chemistry

and Biology). Hence, letter was addressed to the above said Colleges to discharge the above students who have secured below percentage in 10+2 (Physics, Chemistry and Biology) for the academic year 2023-24.

Decision of CAC: As the candidates in the present case belong to the All-India OBC category and have not claimed/admitted under any reservation for their admission, they shall be eligible for admission based on the reduced percentile eligibility criteria as per the Apex body regulation. Hence, the admission they may be considered.

Decision of Syndicate: The Syndicate accepted the recommendations of CAC.

The Syndicate due to legal constraints, ethical & social issues has approved the CAC recommendations. Further, there is a need to reform the LIC procedure to plug the deficiency in the existing system of inspection. Hence, a Syndicate LIC reforms committee is formed to deliberate and formulate guidelines within 2 - 4 weeks with the following members:- Dr Yogananda Reddy Y.C, Dr B-K Madhusudhan & Dr G P Ramanath. DD Authority shall be the convenor for the meeting.


Request of the College:

The meeting concluded with thanks to the Chair and all the members present.




