CIRCULAR

Sub: Nursing colleges charging exorbitant admission fee related to students.

Ref: 1. GOK Notification order No.MED/299/MSF/2023, dated 07.09.2023

2.GOK Meeting Notice No.MED/55/MMC/2024-25, dated 31.08.2024

Adverting to the above subject, it has come to the notice of GOK/RGUHS that some of the RGUHS affiliated nursing college Principal/Management are charging excessive fee for nursing students. The college should not impose fee beyond the Government prescribed limit. As per the GOK order No.MED/299/MSF/2023, dated 07.09.2023, the fee structure chargeable to the candidates seeking nursing admission stands at Rs.10,000/- per year for students admitted under government quota, Rs.1,00,000/- per year under management quota for domicile of Karnataka students and Rs.1,40,000/- per year for non Karnataka students.

Therefore, it is hereby directed to the college Principal to strictly follow the below mentioned instructions.

1. University fees and Govt fee should be charged as per the actuals and no excess fee should be collected.
2. The fee should be uniform throughout the course for all the years should not collect higher fee in the 1st year on lower fee in subsequent years.
3. Students should not be forced to take admission to your college hostel.
4. The details of all the fee chargeable to the students should be displayed in the college at prominent places of the college campus like admission office, principal office, notice board and in the website.

The displayed fee structure on the notice board along with photos should be sent to the university within one week through Email Id: nursing@rguhs.ac.in

5. At the time of inspection the fee structure displayed will be checked.
6. Biometric attendance is compulsory for all the students and staff.

Failing to comply with the afore mentioned directions will be viewed seriously and appropriate action will be taken against such nursing colleges in accordance with RGUHS rules and regulations and also copy will be sent to the Government.
