02	<p style="text-align: center;">Key Highlights</p> <ul style="list-style-type: none"> ➤ For nursing colleges attached to hospitals owned by same trust/society/company that runs the college are eligible for a maximum of 250 seats with a student patient ratio of 1:3 as per annexure 1. ➤ Any Affiliated hospital if shown by your college, it should not be a parent hospital / affiliated hospital for any other existing nursing college. ➤ The nursing colleges should have own building proportional to the requested seats as per the INC norms. ➤ Should have adequate student teacher ratio and patient student ratio as per the INC norms. ➤ Aadhar enabled Biometric Attendance is compulsory for both the students and faculty. ➤ Application is entertained through online portal only. ➤ Revised affiliation fee is applicable for this application Annexure 2.
