b)	All Institutions are strictly instructed to make admissions only after receipt of grant of Affiliation notification for the concerned course and for the concerned academic year from the University.	
c)	Latest Guidelines/Minimum Standard Requirement (MSR) for establishment of Fresh Colleges / Courses for Physiotherapy & AHS to be obtained from RGUHS website (BPT Ordinance 2016 & AHS Ordinance 2018, MPT ordinance 2020 & M.Sc.
